Meet the Artist: Ophelia Chambliss
“The Rhetorical Power of Representation and the Visual Image”

PROGRAM: Ophelia M. Chambliss, artist and educator, has been successfully working and exhibiting as a fine artist for many years in solo and group exhibitions, as well as several distinguished juried shows, and has been recognized for her work on public art projects in York.

She holds a Bachelors in Communication Arts and Sciences, and a Masters in Communications from Penn State University. Ophelia is also serving a term as a Commissioner for the Pennsylvania Historic Museum Commission, and was recently named to the Advisory Board for the PSU Harrisburg Humanities department. She was also awarded the Alumni Achievement Award for her community, and creative work by Penn State University.

Ophelia will present a series of images, while discussing symbolic representations of image, discourse, and story to tell the story behind her work.

“As a public artist and muralist, I pride myself in working with different stake holders with a common goal to build community around art. I work to build collaboration, ownership and a belief in the process and production part of the final piece of art.

As an Academic, I have been addressing the issue of “What is Black art?” Is Black art defined by the cultural content of the art, or the ethnicity of the artist? Much of my work straddles these two distinctions and challenges the limitations that are thrust upon being either. I try to work within the representations of culture, and the Black American Experience, while creating art that is stylized beyond a cultural racial distinction.”

BRANCH SCHOLARSHIPS

Hi, Betty and Carol,

Thank you very much for inviting me to speak at your AAUW meeting last night and making me feel so welcome by taking me out to a lovely dinner before the meeting. Thank you also for the honorarium.

After I finished talking, I realized that I should have ended on a more positive note. So, here are a few things that we can feel very optimistic about when it comes to public education.

In September, **the PA Supreme Court ordered the [PA school funding lawsuit](#) to go to trial.** This lawsuit aims to force the legislature to change the way it funds public schools. The case has been brought on behalf of 7 school districts, the NAACP, the PA Association of Rural and Small Schools, and parents. It alleges that the school funding system violates the PA constitutional mandate to provide a "thorough and efficient system of public education to meet the needs of the Commonwealth." It also alleges that it violates the Equal Protection Clause because some children are denied an adequate education simply because of where they live.

We expect the lawsuit to go to trial sometime within the upcoming year. This lawsuit will shine a very bright light on the vast disparities in PA's school funding system, which will put pressure on legislators to fix it. If the plaintiffs win, the court could order the legislature to change the way it funds schools. In many other state court cases like this one have forced legislatures to take action and have significantly improved school funding issues.

There is also reason to hope that we will see cyber charter reform come out of Harrisburg sooner rather than later. **Brick and mortar charter schools increasingly view cyber charters as a massive weight that is pulling them down and they are increasingly trying to distance themselves from the cybers.**

In addition, people throughout PA are waking up to the outrageous costs of cyber charters and to the terrible quality of education that most children who attend these schools receive. Lawmakers are hearing more and more from their constituents about these issues and feeling pressure in their districts to deal with them.

Finally, a large and diverse statewide campaign, the [Campaign for Fair Education Funding](#) (the AAUW is a member), is increasing its power and has the potential to put significant pressure on lawmakers to fund our schools.

While we face a lot of challenges, for sure, all is not bleak, especially when engaged and informed Pennsylvanians like the AAUW members come together and take action to hold lawmakers accountable!

Thank you again for inviting me to speak at your meeting. If there is anything I can do to help you with advocacy, please let me know. I hope that we'll keep in touch.
