The meeting helped to clarify the direction of our group and the logistics of forging ahead with our ideals and projects for the coming year.

It is with great sadness that we mourn the passing of Supreme Court Justice Ruth Bader Ginsburg. As Kimberly Churches, CEO of AAUW National states, "America lost one of our most beloved role models tonight, a pioneering jurist and iconic feminist who blazed new trails, not only in her own life, but in the lives of the countless women she championed — and inspired." In 1999, Justice Ginsburg was recognized with an AAUW Achievement Award. As AAUW members committed to empowering women and girls, we remember her words, "Fight for the things you care about, but do it in a way that will lead others to join you." Associate Justice Elena Kagan said of Justice Ginsburg, "More than any other person in history, she can take credit for making the law of this country work for women." So, we mourn her, honor her memory, and acknowledge and never forget her subtle yet remarkable impact upon each of us. May she inspire and empower future generations of women and girls.

This year is the 100<sup>th</sup> Anniversary of the 19<sup>th</sup> Amendment. We are planning to have a local historian speak to our group during the year to explain the history, including the participation of women in York County, of this momentous event. Also, there is an exhibit at the York History Center featuring the Justice Bell (Women's Liberty Bell) currently through October 10.

## **GET OUT THE VOTE - ELECTION DAY IS TUESDAY, NOV.3**

There is much confusion about the voting process this year. But one thing is clear. If you opted for mail-in voting, fill out your ballot and send it in immediately.

<u>VotesPA.com</u> is the state resource with all the information regarding voting in Pennsylvania. Links are available to:

- Check your registration status.
- Apply to register to vote or update your registration online.
- Request a mail mail-in ballot
- Check your mail-in ballot status.
- Learn about voting in person at a polling place.

The last day to register to vote is Oct. 19. The last day to apply for an absentee ballot is Oct. 27. The Pennsylvania Supreme Court recently ruled that mail-in ballots will be accepted if they are received by 5 p.m. on the Friday after Election Day and were either postmarked by November 3 or there is no evidence to suggest that they were sent after Election Day.

A secure ballot drop box will be available in the lobby of the Election Office located at the York County Administrative Center – 28 E. Market St. – York, 17403. Check the yorkcountypa.gov website for more information on drop boxes.

# **Declining To Vote By Absentee Ballot**

If you signed up for a 2020 annual mail-in ballot in the spring, and do NOT want to vote by mail in the General Election, you have a couple of options. The best way is to fill out a "Request to Cancel Permanent Absentee or Mail-In Status" form on the county's elections website (yorkcountypa.gov):

- This is a paper form. You must print it, fill it out and mail it to the York County Election Office.
- If you signed up as a permanent mail-in voter in 2020, you will be marked in the poll books as a mail-in voter unless you fill out this form
- Once you fill out the form, and it is received and processed, you will show up in the poll books as an in-person voter.
- If you do not fill out this form, you will be listed in the poll books as a mail-in voter. If you go to the polls, you will have to cast a provisional ballot.

There are some special circumstances where mail-in voters can return their mail-in ballot and their outer envelope and fill out a declaration making them eligible to vote in person on Election Day.

The phone number of the York County Election Office is 717-771-9604. They will be able to answer any questions you may have. You may also check the yorkcountypa.gov website for more information.

## HIGHER EDUCATION FUNDING COMMITTEE (HEFC)

The Graduate and Undergraduate Scholarship Committees' members are now one combined group to support local girls and young women in their pursuit of higher education. This transition gives us more options for working within our budget this year and in future years.

We met via Zoom and decided, with Board review, to develop an opportunity for female York County high school students who are qualified academically to participate in Dual Enrollment programs with our three accredited county colleges. Amber Seidel identified a need among some students who are qualified scholastically but who cannot afford the tuition to gain three college credits - at half of the cost for enrolled college students! Dual Enrollment students are also much more likely to attend college after graduation from high school. We anticipate being able to assist at least four young women students this coming year.

## **PUBLIC POLICY**

AAUW's 2020 Gender Policy Agenda outlines priority issues for the 2020 election season. Here is what AAUW would like to see implemented in Pennsylvania to advance gender equality in the workplace in regard to economic security:

- 1. ENSURE EQUAL PAY FOR EQUAL WORK Pass pay equity bills HB 850 and SB 721.
- 2. IMPLEMENT PAID LEAVE AND PAID SICK DAYS Pass the Family Care Act paid leave insurance program HB 1739 and SB 580 which have bi-partisan support in both the House and Senate.
- 3. STOP HARASSMENT IN THE WORKPLACE The creation of the #MeToo in Pennsylvania General Assembly Act, SB 480 in the Senate and HB 1000 in the House, covers government employees and bans mandatory arbitration and nondisclosure agreements as a condition of employment, codifies strong anti-retaliatory policies. HB 849 also bans non-disclosure agreements.
- RAISE THE MINIMUM WAGE AND ELIMINATE THE TIPPED MINIMUM WAGE Pass
  One Fair Wage HB 1215 to raise the state minimum wage to \$15.00 per hour and
  eliminate the tipped minimum wage.
- 5. CLOSE THE RETIREMENT GAP Require employers to offer a retirement savings plan for workers or create a marketplace to facilitate plan assessments. Analysis of pending bills requires transparency of plans but seems to be mostly directed at government plans.
- 6. PROTECT PREGNANT WORKERS Pass HB 1417 Workplace Accommodations for Pregnant Workers.
