#### **PUBLIC POLICY**

The May 18 Primary will elect judges, school boards and some municipal offices. The last day to REGISTER TO VOTE is MAY 3, 2021. The last day to REQUEST A MAIL-IN OR ABSENTEE BALLOT is MAY 11, 2021. If you voted by mail in 2020, you need to request to do so for this year.

There are also three questions on the ballot:

- 1. Proposed Constitutional Amendment, Article III, Section 9, addresses the governor's emergency powers, including requiring legislative approval to continue beyond 21 days.
- 2. Proposed Constitutional Amendment, Article IV, empowers the legislature to extend or terminate an emergency declaration by resolution.
- 3. Proposed Constitutional Amendment, Article I, prohibits denial or abridgement of rights on account of an individual's race or ethnicity.

# PROPOSED CHANGE TO AAUW BYLAWS - MEMBERSHIP REQUIREMENT

Between April 7 and May 17, AAUW members will vote on a change to the Association Bylaws that would drop the educational requirement for membership. A "Statement from the AAUW Racial and Social Justice Working Group" summarizes the thinking behind this change:

As members of this working group, we are passionate about ensuring that AAUW become more diverse and inclusive. Eliminating the educational requirement for membership is an essential step toward that goal: If we are truly committed to advancing equity for all, we need to become more equitable ourselves. While the [education] requirement may have made sense early in our history, by today's standards it is perceived as elitist, exclusionary and out of touch.

To remain relevant, every organization must evolve. It is essential that we send a loud and clear message that we welcome all who share our values and goals – regardless of whether or not they hold a college degree...

Members have questions about this change. According to the AAUW Website:

- ✓ Education will remain a focus of AAUW.
- ✓ The Board does not expect this change to attract a large influx of younger members, but it may attract members who are interested in organizations that focus on inclusion and diversity.
- ✓ Funders look for diverse organizations. Our educational requirement may discourage corporate support because it is deemed discriminatory.
- ✓ Many talented people want to work with us but have been denied membership because of the educational requirement. We cannot afford to turn people away.
- ✓ It is essential that our membership criteria match our mission and values.
- ✓ AAUW must evolve to survive.

# \$15 Minimum Wage: Who Needs It & Why Should I Care?

[Message from Anne Pehle, AAUW PA President, about Zoom webinar]

There is much talk and activity about raising the minimum wage--at the federal level and in Pennsylvania. It is often a discussion with many misperceptions and inaccuracies. We want to bring you the facts behind the minimum wage discussion and why it is important to the women of Pennsylvania that legislation is passed.

The minimum wage in Pennsylvania is the lowest allowable by federal law and has been \$7.25 for over 12 years. There is nowhere in Pennsylvania, or anywhere else in the country, where a single person can live on \$15,080 a year. Every state surrounding Pennsylvania has a higher minimum wage and more than 70% of PA voters are in favor of raising the minimum wage. So, why haven't voters been heard? Join AAUW Pennsylvania Public Policy Chair, Jacqui Rogers, for a webinar to explore why we aren't being heard and how this affects us all. Jacqui will share the latest economic data, the myths about minimum wage, and current legislation to make the minimum wage a livable wage in Pennsylvania.
