**PROGRAM:** An independent judiciary is central to our democracy and the preservation of public trust in the Rule of Law. Retired Judge John Uhler will explore the genesis of an independent judiciary, its implications on the justice system, and its impact on the judicial ethics.

John Uhler, retired Judge and Counsel at CGA law firm, is a graduate of Bucknell University and the Dickinson School of Law. He served as a Senior Law Clerk in the Federal Court and as an Assistant U.S. Attorney. He was elected District Attorney of York County and elected Common Pleas Judge of York County, in which position he was elected President Judge and later a Senior Judge. He served as President of the Board of the York County Bar Foundation and serves on the Board of Crispus Attucks. He is an active member of the York Rotary Club's Inclusion, Diversity, Equity, and Accessibility Committee.

# **Update on cyber charter school issues:**

Betty Hooker and I have done some research, and have found that this past spring, in the budget bill, the Pennsylvania legislature passed measures to make cyber charter schools more accountable, with greater transparency of their spending as well as student achievement, bringing them in line with the Right to Know Act and State Ethics Act, similar to requirements already in place for public school districts. There are still funding fairness issues to be addressed, but at this time, there is no legislation pending, and likely will not be until after January, when the new legislative session begins.

We have decided to join with AAUW-PA in addressing current education issues. At this writing, a court ruling on the funding formula for public schools is imminent. The issue is that the PA Constitution requires that all students receive equal education opportunities. A suit alleges that the current funding, based on property taxes, is punitive to students in districts with less wealth, and therefore does not meet that constitutional requirement.

We also are hoping that more members will join us in a long-term project to publish a booklet featuring current local public-school teachers who make a difference in their students' lives.
