FROM THE PODIUM

As storm warnings once again flash across our TV screens, preparing us yet again for snow that may or may not materialize, it is difficult to imagine that the time has come to begin preparations for the next AAUW year. On the local, state, and national levels, we are being called to make decisions that will ensure that AAUW can continue to fulfill its mission.

Recent emails from National called attention to Bylaws changes that have been proposed for our consideration as part of the annual business meeting. Most are simple changes in terminology that do not affect the intent of the existing Bylaws. A more significant change is the abbreviation of our AAUW Mission from "to advance gender equity for women and girls through research, education and advocacy" to "to advance equity for women and girls." The rationale is that this conforms to the format expected in paperwork filed with the government.

Public Policy Priorities, a comprehensive list of goals focusing on equity for women and girls in education, economic security, equality, individual rights, and social justice, will remain the same. In order for the constitutional amendment to make it to the ballot, it must be passed in a successive session with the exact same language. This year, however, some extremist groups have organized with the intention of "packing" local school boards with candidates who will attempt to implement their political agenda with specific policies that reflect their own point of view.

You may ask: I don't have kids in my local schools; why should I care who gets elected to the school board?

Here's why:

When extremists enact policies like book bans or discriminatory regulations, they end up spending taxpayers' money and energy and resources of administrative staff to defend lawsuits instead of focusing on the best education for the students.

The quality of education in a school district affects the *value of your home* or property.

Perhaps most importantly, what children are taught in school affects their ultimate attitudes, their critical thinking ability, their voting patterns as adults, and, consequently, it affects the overall character of our community.

As the primary season gets closer, we will be publishing some things to watch or listen for in the candidates, and, I hope, questions you can ask candidates.
