United We Stand: AAUW National's website states: "In principle and in practice, AAUW values and seeks an inclusive membership, workforce, leadership team and board of directors. There shall be no barriers to full participation in this organization on the basis of age, disability, ethnicity, gender, gender identity, geographical location, national origin, race, religious beliefs, sexual orientation or socioeconomic status." *Adopted by the AAUW Board of Directors, June 1988. Several revisions followed. The latest revision was written in June 2018.*

In recent years, AAUW has embraced the concepts of Diversity (welcoming and representation of different dimensions of diversity), Inclusion (ensuring that all individuals have access to the same opportunities and that they are treated fairly), and Equity (building an environment where everyone's thoughts, ideas, and perspectives matter), and has charged the Branches to foster these ideals in their groups and communities. In doing so, we join businesses, organizations, and groups throughout the country. To be most effective, another one is added: Belonging. Unlike the others, Belonging is a feeling of being accepted as a member of a group, valued, and connected with the company or organization. EDUCATION ISSUES ACTION GROUP

Vouchers hurt the Public Schools & Taxpayers

The state legislature is trying to get a voucher bill passed before the reform of the unconstitutional way the state funds public schools, relying on property taxes. By making public taxpayer money available to private and religious based schools, vouchers are detrimental to the local public schools.

- Private schools are still out of reach to low-income families. Statistics of the program already in place indicate that very few low-income students are admitted with vouchers.
- Private schools do not have to accept everyone. They exclude on the basis of religion in some cases, and do not have to offer services to special needs students.
- Currently, there is little financial transparency or academic accountability applied to private schools or to scholarship foundations that accept vouchers.

Let Governor Shapiro know why you support public schools and oppose utilizing taxpayer dollars to fund private schools through a voucher program.

- "Please be the champion of public schools, which the vast majority of PA students attend."
- "As a taxpayer, I want my funds to support local public schools."
- "As a parent, I want my local public school to be the priority."
- "State tax dollars should not support private and religious schools."
- "You have a constitutional obligation to respond to the court decision and fully fund public schools."

PUBLIC POLICY

Earlier this year, the U.S. Food and Drug Administration (FDA) was sued over its approval of mifepristone, part of a safe and effective regimen commonly used in medication abortions. AAUW joined the United States of Women and 140 partners in a People's Brief to demand the courts uphold the law and protect access to mifepristone.

In August, the Education Department's Office for Civil Rights released guidance on "Race and School Programming" to provide information on programs to promote racially inclusive school communities. The move was made in the wake of the Supreme Court's June decision that prohibited the consideration of race in higher education admissions.

On August 25, Rep. Nikema Williams (D-GA-5) introduced a suite of AAUW-supported voting rights bills to ensure "free and fair access to the ballot" for all.
