I have agreed to be Co-Finance Officer, which will be a steep learning curve and greater responsibility for me. I will not have the time or energy to be both that and the education group chair. So, this will be my last article for the *Banter*. Betty Hooker has been very helpful in writing *Banter* articles, and I hope she will continue to do that occasionally.

EDUCATION ISSUES ACTION GROUP

One theme of the articles that Carol Little and I have written for the *Branch Banter* this year is the excess funding paid to public cyber charter schools. On Thursday, May 16, Education Voters of Pennsylvania issued a report that echoes our concerns. They found that:

- The four largest cyber charter schools in Pennsylvania Agora Cyber Charter School, Commonwealth Charter Academy, Reach Cyber Charter School and Pennsylvania Cyber Charter School – have increased their assets from 2018-2022 by 92,000%, an increase of 921x!
- Their net assets increased from \$566,858 in 2018 to \$486 million in 2020.
- Cyber Charter Schools spent more than \$21 million on advertising and gift cards during the 2022-2023 school year.

It is past time for the General Assembly to align the per pupil payments to cyber charter schools to the actual cost of educating their students. It is unconscionable that public schools postpone maintenance and struggle to hire adequate staff members while public cyber charter schools are "rolling in cash" provided by our school taxes. Urge your Legislators to approve the \$8,000 per pupil cap called for in Governor Shapiro's 2024-25 PA State Budget.

COMMUNITY COLLABORATIONS

Recently, our Branch had another opportunity to engage in community collaborations. On May 9, Carol Anderson, Martha Fleischer, Betty Hooker, and I met with Carol Eicher, a member of York College's Board of Trustees, to discuss how our Branch can collaborate with York College. Carol Eicher's mother, Doris Cohen, was a long-time member of our Branch. Carol has followed in her mother's footsteps by becoming a new member of our Branch.

Carol shared information about an endowment she created at York College. The donation supported a 2023 seminar for female STEM students. Another seminar is planned for September 21, 2024. The goal is to provide opportunities for female students to network with other women and hear from female role models. Carol has invited our Branch to identify a couple of designees to attend this seminar. These attendees do not have to be AAUW members, but can be community leaders that we recommend.

Through Carol's contacts with students and York College faculty, she has made these observations: students need female role models, they need help transitioning from college to the workplace, they need to advocate for themselves, they need to find a group that shares their common interests, and they need a good mentoring program. Carol sees that AAUW can be part of that mentoring program.

Our discussions also included ways AAUW can empower and connect with students by encouraging them to participate in AAUW webinars and programs. Another way of connecting is for York College to become an AAUW affiliate.

We exchanged personal stories about Carol's mother. We will continue to explore ways to honor Doris Cohen's legacy.

The collaboration with Carol Eicher has the potential to provide ways that our Branch can be more visible in the community as well as a way of using the skills and talents of our members. Contact me if you have any ideas about community collaborations/outreach.

DIVERSITY, EQUITY, & INCLUSION COMMITTEE

Our committee is focused on enlightening our membership regarding the history and current trends of diversity, equity, and inclusion for all. This past year we have done so with a lecture, book suggestions, and informative monthly *Banter* articles.

During the month of February, our committee sponsored the program at the Branch meeting. Laura West Steck, PhD, Associate Professor of Sociology, York College, was invited to speak about *Critical Race Theory and Contemporary Conversations about Race (Part 1)*. We are hoping to invite her to return to speak more on this very timely and important topic. Also in February, the Book Group read *The Vanishing Half* by Brit Bennett. *The New York Times* rated it as one of the Best Books of 2022. Current DEI issues are shared each month in the *Banter*. Additionally, we made suggestions of books based on relevant themes. We continue to participate with the York County Confronting Racism Coalition. We invite you to continue your understanding by suggesting the following novels by Black writers.

PUBLIC POLICY

Updates on several recent issues at the national level:

- 1. Pregnant Workers Fairness Act (PWFA) The U.S. Equal Employment Opportunity Commission (EEOC) issued final regulations for how to implement PWFA on April 19. The rules require that employers provide "reasonable accommodations" to employees related to pregnancy, childbirth or related medical conditions, including abortion. There are several efforts to obstruct the law's implementation, including a lawsuit filed April 25 by 17 states. A Texas federal district court ruled in February that state employees are not covered by PWFA.
- 2. Workplace Harassment On April 29, the EEOC published "Enforcement Guidance on Harassment in the Workplace". The guidance is a comprehensive resource providing best practices for preventing and remedying harassment. It includes examples illustrating unlawful harassment, including situations involving older workers and survivors of gender-based violence. The guidance also addresses recent updates in the legal landscape of harassment claims, such as the U.S. Supreme Court's decision in BOSTOCK v. CLAYTON COUNTY (2020), in which the court held that Title VII's protections extend to discrimination based on a person's gender or sexual orientation.
- **3.** Overtime Rules On April 23, the Biden administration issued a final rule "Restoring and Extending Overtime Protections". The rule provides additional protections for 2.4 million women workers (about the population of Kansas) who are overrepresented in low-paid jobs, working long hours for often near-poverty wages. The rule goes into effect on July 1, 2024; legal challenges are expected.
- **4.** Noncompetes On April 23, the Federal Trade Commission (FTC) issued a final rule which bans contracts known as noncompete agreements, which prevent workers from leaving for a competitor for a certain amount of time. In the rule making process, FTC considered evidence that noncompete clauses negatively impact racial and gender wage gaps. The final rule will become effective 120 days after publication in the Federal Register. The U.S. Chamber of Commerce has filed a challenge to the rule in federal court.

HIGHER EDUCATION SCHOLARSHIP COMMITTEE

The Higher Education Scholarship Committee recently met to reorganize the committee. As a result, I offered to chair the committee. On behalf of the committee, I want to recognize and thank Nancy Spataro for her leadership, experience, and hard work during the past few years when she was the chairperson. Secondly, I want to recognize and thank Bonnie Bluett who facilitated the scholarships for this year. As Co-Finance Officer, she went far "beyond the call of duty" in communications with scholarship winners and their families, as well as the local high schools and colleges that the students attend. The following year-end report is written by Bonnie:

HIGHER EDUCATION SCHOLARSHIP COMMITTEE – SUMMARY FOR 2023-24

During our 2023-24 fiscal year, we sponsored two Dual Enrollment students at H.A.C.C. We sponsored Olivia Farag, a junior at Central York High School, for an Introduction to Philosophy course in the fall semester. Our second Dual Enrollment student was Nomey Kahn, a junior at West York High School, who was unable to attend our May meeting, but sent the following note for us to share with our members:

Hello, my dual enrollment experience was amazing and thanks to your sponsorship I was able to take a class that I believe has greatly benefited me, especially in the long run. I personally want to go into the medical field and become a physician's assistant, and with my scholarship I was able to take a class that would Immensely further my knowledge and education when it came to the entire human body which is exactly what I needed as it pushed me a step further in my journey to where I want to be. I genuinely cannot be anymore grateful than I already am for the opportunity you all have given me, so thank you so much. Now, I understand that my say is not end all be all, however I do believe that the Scholarship Committee should continue to fund and support students like me who have big dreams. I say this because there are many students out there who go through so much worse in life who just want to do good and want to be someone who can make a difference. I truly believe that with an opportunity like what I had been given, it'll make things just one step easier. Which really is a much bigger step than anyone truly sees.
