BRANCH AWARDS

York Branch is given the opportunity to present three awards annually through the sponsorship of our state organization, AAUW-PA. The honorees are recognized by AAUW-PA, and members receive a certificate recognizing their accomplishments. These awards are not required, but an opportunity to recognize women that we determine should be honored.

The **Gateway to Equity Award** is given to individuals or organizations that have shown by action and philosophy that they advance equity for women and girls through advocacy, education, philanthropy, or research. This award is selected by the Branch Board members.

The **Member Making a Difference Award** is given to a member who has made a big difference in something important to the Branch within the last year. This person need not be an officer or a committee chair.

Outstanding Woman Award

- She has provided meritorious service to the Branch and the community over multiple years.
- She may not be the current president.
- The state allows two nominees for this award from the Branch.

Other Optional Awards

York Branch Special Honoree – may be given to someone who has been active for many years who deserves recognition but does not qualify for the other awards.

AAUW-PA Special Honoree – This award is given by the State Board to someone who has been active at both the State and Branch levels or has given extraordinary service to the local branch.

Check our *Yearbook* for past honorees. Please submit your nominations in writing **by January 15, and please give examples of the person's accomplishments in a brief statement**. DEGREE EQUIVALENCY POLICY FOR MEMBERSHIP

We are excited to provide you with this new policy information summary. Many of us know someone who is aligned with the mission of our organization and they have had some higher education, but not the standard educational degree.

National AAUW adopted a new policy in June, 2025, which specifies the process for assessing credentials for membership based on degree equivalence. It allows membership for individuals who have received the equivalent (e.g., RN) of an associate degree from an accredited higher education institution.

1. All prospective members should demonstrate a commitment to working to advance equity for women and girls.
2. Determination of eligibility is based on one or more of the following:
 - a. At least two (2) years of full-time or 48 credit hours equivalent education at an accredited institution.
 - b. Holding of certificates, licenses, or professional certifications issued by a higher education institution accredited by a recognized agency.

Requests may be made and submitted to executive@aauw.org or connect@aauw.org by the individual directly, or by an AAUW affiliate (branch) member on behalf of the individual.

Decisions are made by the national AAUW Board of Directors.

PUBLIC POLICY

Looking ahead, National AAUW will be involved in several key policy fights in 2026 including the following: (1) AAUW is tracking how the 'One Big Beautiful Bill' budget law will reshape education. The bill created a national K - 12 tax-credit voucher system, and the Department of Treasury had sought public input until December 26. (2) There will be comment opportunities on the Department of Education's proposal to redefine graduate and professional students, monitoring FY26 appropriations, and following executive orders to revamp college accreditation. (Note: Nursing has been re-classified as a non-professional degree/program, which will result in a decrease in the amount of government funds available to pursue graduate level education.) (3) On January 13, 2026, the U.S. Supreme Court will hear Little v. Hecox, a major case on transgendered students' rights. AAUW joined an amicus brief in support of transgender students. On a separate matter earlier in December, AAUW's Lobby Corps celebrated more than 50 years of volunteer advocacy advancing equity for women and girls.

DIVERSITY, EQUITY, & INCLUSION COMMITTEE

Several years ago, our York Branch established a partnership with the Confronting Racism Coalition. The Coalition's mission is 'to create sustainable change by breaking down system racial barriers and promoting healing, equity, and inclusion for all. Its vision is for York to be a place where differences are valued and equity prevails.' Their mission and vision fit well with AAUW's mission.

Representatives from the Diversity, Equity, and Inclusion Committee frequently attend the Coalition's monthly meetings and learn what is happening in the community and the impact that the Coalition is having in our community. As an example, we have learned that the Coalition has influenced policy decisions in schools.

At the most recent Coalition meeting, there was a discussion about the Coalition's accomplishments during 2025. One accomplishment that was particularly meaningful to the Coalition was receiving AAUW PA's Gateway to Equity Award. This award, given by our Branch, recognized that the Coalition shows by their actions and philosophy that they advance equity for women and girls.

Another major accomplishment was the development of the Coalition's new website. The website provides excellent information about its history, what they do, and the impact it has in our community.
